As of rendezvous 2004, The FBRA Board of Directors has made a decision to make the Fort Bridger Rendezvous an Invitation Only Event. Traders will be judged according to Trade Items, Food items, Display, Personal Conduct and Compliance with the Rules and Regulations. Violations may result in a loss of invitation.

By submitting an application and Fees, this does not guarantee a Trade Space on the Fort Grounds. Your cleared check is not a guarantee. FBRA encourages all traders / venders to apply. If you wish to be eligible for a Trade / Vender Space, your application must be postmarked by January 1, 2019. All spaces after January 1, 2019 will be charged a \$10.00 late fee and will be filled on a first come first serve basis. F.B.R.A. Members will be given first priority. Applications for 2019 rendezvous will be accepted Friday, August 31 thru Monday, September 3, 2018 in Registration. Confirmations will be mailed out no later than April 1, 2019 for applications submitted by January 1, 2019.

No refunds will be issued after August 1, 2019
